1 APPLYING FOR 2026 UNIVERSITY ADMISSION

Year 12 students applying to Curtin University, Edith Cowan University (ECU), Murdoch University and The University of Western Australia must apply through TISC.

Applicants for WA Academy of Performing Arts (WAAPA) courses should apply directly to ECU but also complete a TISC application if they wish to be considered for courses offered elsewhere, including ECU campuses.

Applicants for The University of Notre Dame Australia can choose whether to apply directly to the university, or through TISC.

Applicants for Notre Dame's Young Achievers Early Offer Program should apply directly to the university. Applicants who select an eligible Notre Dame degree as their first preference on their TISC application may also be considered for an early offer via TISC. Please note, the Bachelor of Biomedical Science (Assured Pathway to Medicine) is not eligible for early entry, and all applications for this degree must be made via TISC.

University applications through TISC opened on Tuesday, 3 June 2025. An updated list of important dates and deadlines is available on the TISC website.

2 MULTI-FACTOR AUTHENTICATION

New this year is multi-factor authentication which is required for all Year 12 students when logging into their TISC account

3 EARLY OFFERS

The first round of Year 12 Early Offers will be released on **Monday 1 September 2025**. There will be three or four further rounds of Early Offers – confirmed dates will be available shortly on the TISC website.

Most early offers will be conditional, so students should carefully read their offer letter so that they know what is required. Students should be aware that not all courses are available for early offers. Generally, courses with limited places, and university enabling programs do not make early offers; for specific lists of courses excluded from early offers, check the university websites.

Early offers will continue to be made based on final Year 11 results, as it is not feasible to use mid-year Year 12 results.

4 2026 TISC GUIDE - GOING DIGITAL!

The 2026 TISC Guide will be a digital-only publication, in line with most other Australian states. In an ever-changing admissions environment, this will allow us to publish slightly earlier and to amend information if required. It will also save around 100 trees per year! The TISC Guide will be available as a full PDF download (which can be printed as required) and as an embedded flip book on the TISC website. The publication date is yet to be confirmed but is expected to be in early July.

5 PERSONALISED LETTERS TO YEAR 12 STUDENTS

If your school would like to receive a PDF batch of your students' personalised letters, which you can then print or distribute electronically (eg email, SEQTA), please email applications@tisc.edu.au with the subject line "Request for Year 12 personalised letters". These will be sent as **one batch per requesting school**. Letters cannot be sent individually. The request must come from an official school email address and include an official email signature. TISC reserves the right to conduct further verification of the sender's right to request this information before supplying the file. The last date to request this information is **Friday**, **22 August.**

For those who do not receive personalised letters, an information sheet about Year 12 students' initial login details is available on the TISC website under Resources>Downloads>Year 12.

6 SCHOOL LEAVERS ADMISSION REQUIREMENTS BROCHURE

The Admission Requirements for School Leavers for 2028 Brochure (2027 Year 12 students) is now available on the TISC website. The brochure can be found under <u>Undergraduate>Entry</u> <u>Requirements>School Leavers</u>.

TISC encourages this resource to be used by Year 10 students and their parents, who are interested in a university pathway, and to assist with the consideration of their subject choices for senior school.

7 TISC PRESENTATIONS TO SCHOOLS IN 2025

There are limited vacancies available for TISC representatives to provide presentations to groups of teachers, career practitioners, Year 12 students and/or parents from now until September.

These presentations can be done in person, or online via Microsoft Teams, subject to resourcing and travel time. Presentations are tailored to the audience, the academic time of year and the amount of time allocated, and can cover the following topics as required:

- university admission requirements
- alternative entry pathways
- marks adjustment processes
- the application process
- structuring preferences
- early offers
- the offer process

Bookings should be made online via Microsoft Bookings.

The PowerPoint presentation available on the TISC website is updated from time to time through the year as new information becomes available.

Due to resourcing constraints and the increased demand for school presentations, it is unfortunately not possible for TISC to visit a school more than once. If you are looking for more than one presentation, we would suggest two consecutive presentations on the same day provided the total booking time is not more than two hours.

8 FREE TISC WEBINARS

TISC will run several free evening webinars during 2025 for parents, students, school staff or other interested parties. A list of dates will be available shortly.

9 PREDICTED ATAR

The ATAR calculator on TISC's website should not be used to predict future ATARs. Adding together four scores based on raw subject scores does not give an accurate TEA and therefore can result in an incorrect outcome.

TISC does not endorse any third parties that claim to calculate a predicted ATAR, and caution should be used in procuring any such service.
